Approve minutes: Rochelle Koerbel motioned to approve the minutes from March 2020, Elizabeth Hardy second.

Approve Treasurer's Report: Colin Fink reported the current membership is 29 members with \$1,400.00 in revenue. \$325.00 will be used for the senior ad in this year's yearbook. The budget will be approved at the next meeting.

President's Remarks: Brian Abt welcomed everyone and introduced the current board.

Sponsor Remarks: Jeanie Cygrymus reported that Kelly Barefoot is working on licensing, streaming and broadcasting rights for the Fall Play. Subscribers will be given an access code to watch on their computer or smart TV over the entire weekend.

Programs will be available to download.
