# Jeanie Cygrymus (Sponsor)

- Introduction of new co-sponsor: Lorraine Mszanski
  - Lorraine is current executive director of South Park Theater. She is familiar with our program and excited to join the creative team. She has experience in choosing shows, grant writing, directing, and many other aspects of theater show production. She holds a theater degree. She has choreographed for South Park High School musicals and worked with River Arts in Elizabeth and Little Lake Theater.
  - Board and attendees welcomed Lorraine and look forward to working with her.
- Little Women
  - Jeanie expressed that the play was well received by the audience and community. She relayed that this show was one of the most tech-heavy shows done by PTHS. It required significant work by stage crew and especially noted run crew's effort to manage all of the on stage props Classic plays can be difficult to perform and the cast excelled at the challenge. Many thanks to parent volunteers that helped make the show a success and congratulations to entire cast and crew.

  - Awards ceremony will begin promptly at 5:00 pm
  - Seniors will receive panos on their way off of the stage, handed out by board
- Conference
  - To be held in January 2025

- Site is West Chester University and must be held while college students are on break
- Students will leave school on 1/2/25 (first day back from holiday break)
- PTHS will perform a One Act
  - Presents a challenge, as rehearsals must be held prior to holiday break.
    Jeanie will explore any opportunities to meet during break.
- Will only be available to Juniors and Seniors, per Dr. Pavlik. In the past, sophomores were invited according to number of points earned and space available. Missing school immediately after break is not ideal, so additional students will not be attending.
- Jeanie and Lorraine will both attend
- 2024-2025 Productions
  - Fall play has tentatively been set-Romeo and Juliet, directed by Kelly Barefoot and to be held the second weekend of November
  - Coffeehouse-December 6-8
  - Spring Musical: To be held one week later due to other scheduling conflicts (3/20-3/23)
    - Mr. Cygrymus, Nikki Uram, Mr. Perrote will again lead
  - Spring Play: unsure of date at this time. Spring Break (4/14-4/21) and music trip (4/23-4/27) dates will limit availability for rehearsals. Little Women was produced in 5 weeks and was a challenging timeline.
- Jeanie extended her appreciation to Backers Board for their support and parent volunteers for their contributions.

- Requested approval of minutes from 4/10/24 Backers Meeting
  - Motion to approve by Anne Gavorcik; 2nd motion by Cari Williams
- Vote on 2024-2025 Tech Director Salaries, Fall and Spring Plays, totaling \$2,036
  - o Total Director Salaries paid for 2023-2024: \$4,049
    - Fall Play: \$1,018
    - Sponsor/One Act for Conference: \$1,000
    - Musical: \$1,531 tech director, \$500 carpenter
    - Spring Play: \$1,018
  - Explanation provided by Kristianna: District funds one director (Sound/Lights or Set) in fall and spring. In 2017, vote added to by-laws for Backers to provide the funding for an additional tech director
  - Question presented by Julie Collins regarding Thespian Backers responsibility to pay this additional salary. Additional discussion held where other members asked availability of Drama Fund. Kristianna expressed that Drama Fund has paid for Independent Contractors to perform additional work for productions. Questions regarding payments to/from this fund should be publicly available and can be directed to Stephanie McLaughlin in the front office. Michelle Skillings offered that additional funds were needed for costumes for each production and that she personally provided the funding needed.

- Rochelle Koerbel made motion that Backers do not provide funding for additional tech director for 2024-2025 school year. Second motion made by Julie Collins. 5 additional members voted in favor of this motion and it was passed.
